Screed Terminology



Floor screeds are used to repair, smooth, level and fill concrete or timber substrates.

To help clarify construction industry meanings allnex have produced the below diagrams and definitions.


Engineers bagged screeds are designed to be mixed with either Water or a Polymer Resin type liquid sometimes referred to as "milk or PVA", these screeds enable the user to apply thinner sections of floor, which can be higher in strength and faster curing than a standard bagged concrete mix or builders mix.


The screeds can vary from heavy duty trowelable rapid set mortars to self-levelling, feather finish, highly fluid mortars that can be feather finished, finished to 0mm.

Floor levelling improves the application, appearance and will increase the life of the top covering finish.


Two part screeds, screeds mixed with polymer will bond more effectively, generally have a higher Mpa and will possess some flexibility and impact resistance.


1 Flat v Level
